Measurement periods that include 2020 & 2021 will be impacted by COVID-19. This will be seen as a temporarily reduced emission and not something the business is able to continue, as a trend, or repeat.

Carbon Reduction Targets.

Commitment to achieving Net Zero

Latcham Direct Ltd are committed to achieving Net Zero by 2040 at the latest.

There are no existing carbon emission reduction targets on which to report any progress currently.

In order to progress towards Net Zero, we have initially set carbon reduction targets to 2025. During this time, we will set our targets for the remaining period to ensure we reach Net Zero by 2040.

Carbon Reduction Initiatives

The following environmental management measures and initiatives have already been, or are soon to be, implemented.

- Appoint Positive Planet as our sustainability partner and communicate journey externally.
- Commit to measurement and reduction year on year as aligned with Science Based Targets, by following actions and recommendations specific to the organisation.
- Commit to data tracking via sustainability audit or survey to request further information
 regarding environmental and low emissions credentials plan to send these to the Top 5/10
 suppliers by spend. This data collection will support reduction journey by gathering
 important data for year two measurement & encourage supply chain integration towards
 Net Zero.
- Based on the above data collection implement procurement policy to support further supply chain analysis and low emissions tracking.
- Support colleagues with active travel and low emissions travel by exploring internal
 initiatives such as Cycle to work schemes, EV charging points, 100% EV lease schemes (where
 appropriate) and car/journey sharing options.
- Create and implement a Green Team initiative internally to share best practice, create a spare for sharing and support colleagues with their own *Carbon Shadow* reductions.
- Commitment to continue to partner with organisations such as The Woodland Trust
- Commitment to continuing to use R32 refrigerant systems where appropriate to keep fugitive emissions low.

We plan to implement further measures which will continue to drive down emissions. We are considering several initiatives and those listed below are some examples of areas we are discussing and the potential impact they may have to our emissions.
